### NOTE: FOR PERSONS WITH DISABILITIES CATEGORY (PWD):

A total of eight (8) posts of Assistant Professors amongst the Departments of Psychiatry Radiology, Radiotherapy & Radiation Medicine, Pulmonary Medicine, ENT, Microbiology, Physiotherapy(Physical Medicine & Rehabilitation) are reserved for Persons with Disabilities. Certificate issued by the Medical Practitioner, Hospital or any other Institution will not be considered.
