**All the applicants are advised to bring their original certificates and other relevant documents for verification at the time of interview.**

#### Eligibility

- i) A Master's degree in Commerce / Business Management with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) and (50% for SC/ST/Physically & Visually Handicapped) from an Indian University, or an equivalent degree from an accredited foreign university.
- ii) Besides fulfilling the above qualifications, the candidate should have either cleared the National Eligibility Test (NET) conducted by the UGC, or similar test accredited by the UGC like SLET/SET.
- iii) Notwithstanding anything contained in sub-clauses (i) and (ii) to this Clause 4.4.1, candidates, who are, or have been awarded a Ph.D Degree in accordance with the University Grant Commission (Minimum standard and Procedure for Award of Ph.D Degree) Regulations, 2009, or the subsequent Regulation if notified by the UGC, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions.

Further, the award of degrees to candidates registered for the M.Phil/Ph.D programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/ By laws/ Regulations of the Institution awarding the degrees and the Ph.D candidates shall be exempted from the requirement of the minimum eligibility condition of “NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities / Colleges / Institutions subject to the fulfilment of the following conditions: -

- (a) Ph.D. degree of the candidate awarded in regular mode only;
  - (b) Evaluation of the Ph.D. thesis by at least two external examiners;
  - (c) Candidate had published two research papers out of which at least one in a refereed journal from out of his/her Ph.D. work;
  - (d) The candidate had presented two papers in seminars/conferences from out of his/her Ph.D. work;
  - (e) Open Ph.D. viva-voce of the candidate had been conducted.
- (a) to (e) as above are to be certified by the Vice-Chancellor/ Pro-Vice- Chancellor/ Dean (Academic Affairs)/Dean (University Instructions)”

The honorarium will be of Rs. 25000/- per month. The candidate shall have to give an undertaking that he/she will not draw any fellowship/Stipend or any financial assistance from any agency till they are teaching in this department as a guest faculty. The candidates who are already availing JRF Scholarships in the University are not entitled for the honorarium, but they will be issued experience certificate for the guest faculty.
